Legal Definition of 'Father' by State - FindLaw - States that another man is an acknowledged or adjudicated father; or c. Falsely denies the existence of a presumed, acknowledged, or adjudicated father of the child.
3. A presumed father may sign or otherwise authenticate an acknowledgment of paternity.

A man is presumed to be the biological father of a child if: (a) he and the child's biological mother are or have been married to each other and the child is born during the marriage, or within 280 days after the marriage is terminated by death, annulment, declaration of invalidity, dissolution, or divorce, or after a decree of legal separation is entered by a court.

The Rights of Presumed (Putative) Fathers: Summary of ... - A Denial of Paternity (DOP) is a legal form signed by a presumed father that states (under penalty of perjury) that the presumed father is not the child's genetic father. To be valid, the child

genetic father and mother must also sign an Acknowledgment of Paternity (AOP) and both the DOP and the AOP forms must be filed with the Vital Statistics Unit.
